

Terms and Conditions

1. The Promoter is Lendlease Property Management (Australia) Pty Ltd of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (**Lendlease**). Contact number is 1800 233 066.
2. Only residents of Australia aged 18 years of age or older (**Participant**) are eligible for the Competition. The following person(s) are ineligible to enter the Competition:
 1. employees of:
 1. any retailer within Tweed City Shopping Centre;
 2. the Promoter; and
 3. the Promoter's related bodies corporate (as that expression is defined in the *Corporations Act 2001* (Cth), and associated agencies, companies and contractors; or
