

MOTHER'S DAY FREE GIFT WITH PURCHASE PROMOTION – TERMS & CONDITIONS

Terms and Conditions

1. The Promoter is Lendlease Property Management (Australia) Pty Ltd of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (**Lendlease**). Contact number is 1800 233 066.
2. Only residents of Australia aged 18 years of age or older (**Participant**) are eligible for the Competition.
3. The following person(s) are ineligible to enter the Competition:
 - (a) employees of:
 - (i) any retailer within Tweed City;
 - (ii) the Promoter; and
 - (iii) the Promoter's related bodies corporate (as that expression is defined in the *Corporations Act 2001* (Cth), and associated agencies, companies and contractors; or
 - (b) members of the Immediate Families of the employees referred to at paragraph 3a.

Immediate family means any of: a spouse or domestic partner, ex-spouse or ex-domestic partner, de-facto spouse or ex-de-facto spouse, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or first cousin.
4. The Promotion commences from 10.00am on Wednesday 8 May 2024 until 2.00pm on Saturday 11 May 2024, or once the allocated gifts have been exhausted (Promotion Period). A maximum of 88 gifts will be available each day during the Promotion Period.
5. The Promoter may extend the Promotion Period at its sole discretion (Extended Promotion Period). Details of any Extended Promotion Period will be posted on www.tweedcity.com.au. References in these terms and conditions to the Promotion Period include any Extended Promotion Period, where applicable.
6. The 'free gift' is 1 x Bloom Rose (**Free Gift**). A total of 350 Free Gifts will be available with a total value of \$3,430.00 in Free Gifts.
7. To redeem a free gift the Participant must provide personal details for the Promoter to record, and present original in-store printed receipt, evidencing a total spend of \$70.00 or more in a single transaction during the Promotion Period at participating Tweed City Fashion, Beauty or Homewares retailers outlined in clause 14. If the Participant is under the age of 18 years, the Participant's parent or guardian must accompany the Participant in order to collect the free gift and the free gift will be awarded to the Participant's parent or guardian.
8. To redeem a free gift the Participant must visit the 'Bloom Bar' at Tweed City, located near Cotton On Body, during the Promotion Period or once the allocated gifts have been exhausted (whichever comes first). There will be a registry of all free gifts claimed at the Bloom Bar.

Even if the purchases have exceeded the criteria of the Promotion, a total 1 Free Gifts can be redeemed. Once a receipt has been presented and validated by the Promoter, no balance amount or part thereof can be used for future redemptions.
12. Only 1 receipt can be submitted to evidence the total spend required.

13. The Promoter reserves the right to mark a receipt to signify the receipt has been used to redeem a free gift.
14. Participating retailers for this Promotion include all retailers within Tweed City that predominantly sell items in the following categories: Fashion, Beauty and Homewares. Participating Retailers are set out in Annexure A (**Participating Retailer**).
15. The Free Gift is not redeemable for cash.
16. The Free Gift is personal to the winner. It cannot be transferred, exchanged or otherwise dealt with.
17. The Promoter assumes no responsibility for lost, misplaced, destroyed or stolen Free Gifts once they are claimed.
18. The Promoter reserves the right to refuse this offer to any person and reserves the right to request winners to provide proof of age and identity and eligibility to participate in the Promotion. In the event that a winner cannot provide suitable proof, the winner will forfeit the Free Gift in whole and no substitute will be offered.

Nothing in these terms and conditions is intended to exclude, restrict or modify rights which the Participant may have under any law (including the Australian Consumer Law) which may not be excluded, restricted or modified by agreement ('Your Consumer Rights'). Subject to Your Consumer Rights, the Promoter is not liable for any loss or damage however caused (including by negligence), suffered or incurred in connection with the Promotion or any gift. Any condition or warranty which would be implied by law into these terms and conditions is excluded.

As a condition of accepting a Free Gift, the winner (or the winner's parent or guardian), and any other person(s) sharing the Free Gift with the winner, may be required to sign legal documentation as and in the form required by the Promoter including but not limited to a further agreement to exclude liability of the Promoter for certain loss, damage or injury arising from the use or participation in a gift to the extent the Free Gift is or includes a recreational service or activity.
21. The Promoter may cancel the Promotion and not award the Free Gift(s) where circumstances beyond the Promoter's reasonable control prevent the Promoter from providing the Free Gift(s). Should the Promoter cancel the Promotion the Promoter will:

 - (b) promptly destroy all entries received; and
 - (c) not use the personal information that any Participant has provided on the entry form.
22. All gifts are accepted entirely at the risk of the winner, and the Promoter excludes all warranties in connection with any gift to the extent permitted by law. The Promoter reserves the right to substitute any gift with a gift of equal or greater value (including where the gift is unavailable) for whatever reason, subject to approval of the gaming authorities in each State and Territory where required.
